EGYPT EXTENSION: Jan. 13 to 18 includes visits to the Egyptian Museum, Memphis, the Pyramids, Sakkara, and Giza. Enjoy the overnight sleeper train to Luxor. Visit Karnak and Luxor Temples, the Valley of the Kings, and the Valley of the Queens. Travel to Cairo by train. Enter the famous Mohammed Ali Mosque, The Citadel, Old Cairo, and more. Fly to Amman for overnight. Return home on 1/18/09.

“AGREEMENT” Registration constitutes acceptance of this agreement by the passengers.

PAYMENT: A \$300 deposit per person is required for registration. Register by June 10, 2008** to receive the Petra excursion and Jerusalem evening free. Register by July 4, 2008** to receive a free Jerusalem Evening. Pay in full by Labor Day for a free \$45** Masada trip. Full payment is due by Sept. 15, 2008. Full payment must accompany registrations received after Sept. 15, 2008. Late payments are charged \$45 late fee. Note: All prices are in US dollars, based on the exchange rate on 3/1/08. If the rate changes, there may be price adjustments prior to departure.

AIRLINES: Air transportation will be provided by using economy class, aboard Royal Jordanian Airlines, with nonrefundable, unchangeable tickets for groups of 20 or more with the same itinerary. Flight times are subject to change by the airlines without advance notice. Alpha Christian Travel Services, Inc. accepts no responsibility for such delays and will not reimburse any expenses caused by such delays. Airline tickets cannot be changed or refunded after being purchased. * Fuel surcharges will be added to the trip cost. They may increase prior to departure.

ACCOMMODATIONS: Hotel rooms are based on double occupancy. ACTS will provide single rooms at an additional charge of \$59 a night if available. Single rooms are often smaller than double rooms. ACTS can try to find a roommate, but cannot guarantee one. If itinerary changes necessitate extra nights, charges will be \$115 per person – per night, for double occupancy, plus any applicable single room charges.
